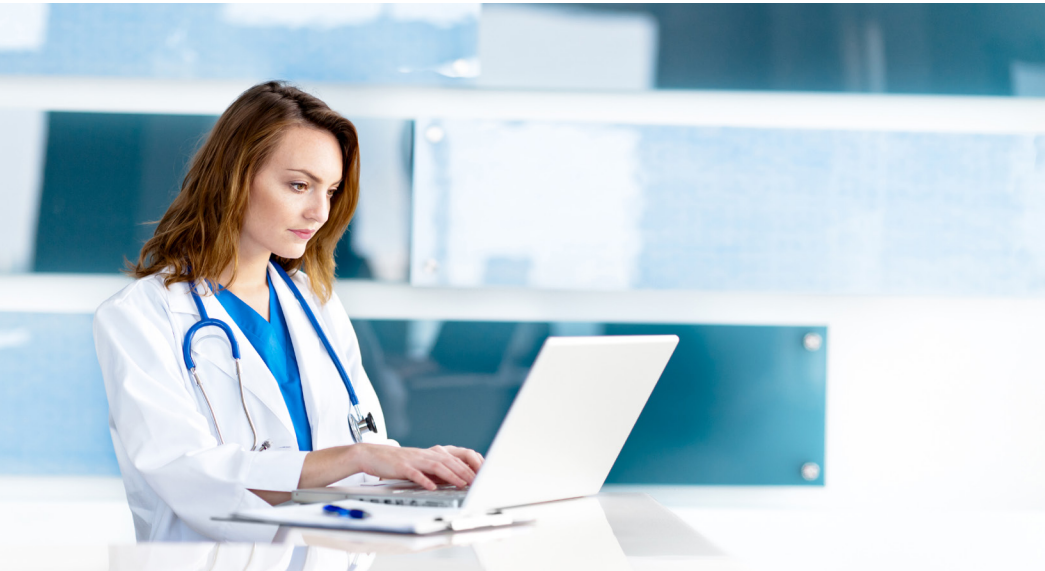


# Greenville Health System Ensures HIPAA Compliance with Absolute
